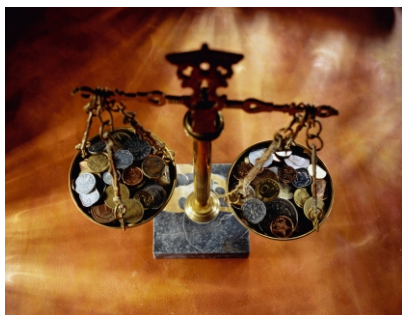

CARRIER SERVICE UPDATES

ASIA-USA

CSAV is pleased to announce that the Pacar Service has expanded its coverage to include a direct call to Xingang. The weekly service calls the following port locations: Ningbo, Shanghai, Qingdao, Xingang, Busan, Manzanillo, Cartagena, Rio Haina, Savannah, Charleston, Port Elizabeth, and Lazaro Cardenas.

ASIA-ECSA

K Line, Pacific International Lines (PIL), NYK, and HMM have reached an agreement to launch a joint service between the Far East and the East Coast of South America. Starting in mid-June, the weekly service will provide the following port coverage: Shanghai, Ningbo, Hong Kong, Shekou, Singapore, Santos, Buenos Aires, Montevideo, Navegantes, Paranagua, Rio de Janeiro, and Cape Town (only offered by K Line and PIL).

EUR-M. EAST/ASIA

Maersk Line announces the addition of Pipavav to the ME3 Service, which covers the Europe - Middle East & South Asia network. The goal of the service enhancements is to provide direct service between North India and the Mediterranean. Starting in April, the port rotation will include the following locations: Gioia Tauro, Algeciras, Tangier, Tarragona, Port Said, Salalah, Jebel Ali, Pipavav, and Nhava Sheva.
